Recognition of Guests

Irene Makar requested that the Township help promote the Ezzyk-Makar Little Free Library, by posting on the Township website. Makar also expressed her concerns regarding dead trees that risk falling onto the roads. Supervisor Hess expressed his concerns as well, that we have been working on them and explained that the Township is only able to perform work on trees that are along Township roads, not state roads.

The meeting was suspended to conduct a hearing for the 2015 International Property Maintenance Code Ordinance.

Guests presented questions and discussions were conducted about the proposed ordinance. At the conclusion of the discussion.

Supervisor Thakore made a motion, and Supervisor Hess seconded the motion, it passed 3/0 to adopt the 2015 International Property Maintenance Code Ordinance. The hearing was closed at this time and returned to the regular meeting.

Police Report

Chief Tom Frace gave the Briar Creek Township Police report. He reported there were 41 total calls answered this month, 34 incidents investigated, 1 magistrate hearing attended, 4 traffic accidents investigated, and 11 traffic citations issued. Chief Frace reminded everyone that the annual "Back the Blue" event will be held at 3 Dogs Vino on September 16^{th,} 2023. In reference to the PCCD grant, the police department was chosen for the 1st quarter "monitoring audit" in which the paperwork was submitted and their monitoring case has been closed with no problems noted. The department will be installing interview room cameras on August 24th, and their LPR and vehicle cameras will be installed shortly. The current Chief's group is starting a crime group to specifically go over the criminal activity in the area. Chief Frace reported that the department does have some leads on recent break-ins in the area.

Zoning Report

The Zoning Report was given by Jackie Hart. She issued one permit this month and has an upcoming meeting with the Solicitor Tony McDonald regarding an ongoing issue. Supervisor LeVan motioned to appoint Jackie Hart from NEIC as the North Centre Township building code official, seconded by Supervisor Thakore, it passed 3/0.
